## 1. Executive Summary

This report presents an overview of compliance and service delivery performance for November 2025 across key Business Enabling Environment (BEE) agencies in Enugu State. Efforts to increase transparency, improve turnaround time, and resolve grievances have been effective, with more than 75% of all requests handled within stipulated timelines.
